WIEBE: That the Administrator work with Crosby Hanna & Associates to implement changes to our zoning bylaw that allows Wet proofing for garages and shops, when approved by an engineer or architect, requiring a concrete foundation or one built from treated wood to the Minimum Building Elevation (MBE) ensuring all mechanical and electrical components are above the MBE as determined by Sask Water Security Agency and that for the purpose of this provision, sheds not on a foundation are exempt from meeting the MBE and that we further allow in the Agriculture or Forest Zoning Districts, a 1 story shed under 200 sq ft that must be on skids that cannot be hooked up to the power grid or natural gas and must have an approach to the property and does not require a dwelling to exist prior to placement and that only 1 shed is permitted per property until a dwelling has been constructed or moved onto the property then the number of accessory buildings allowed will follow the provisions within our zoning bylaw.
