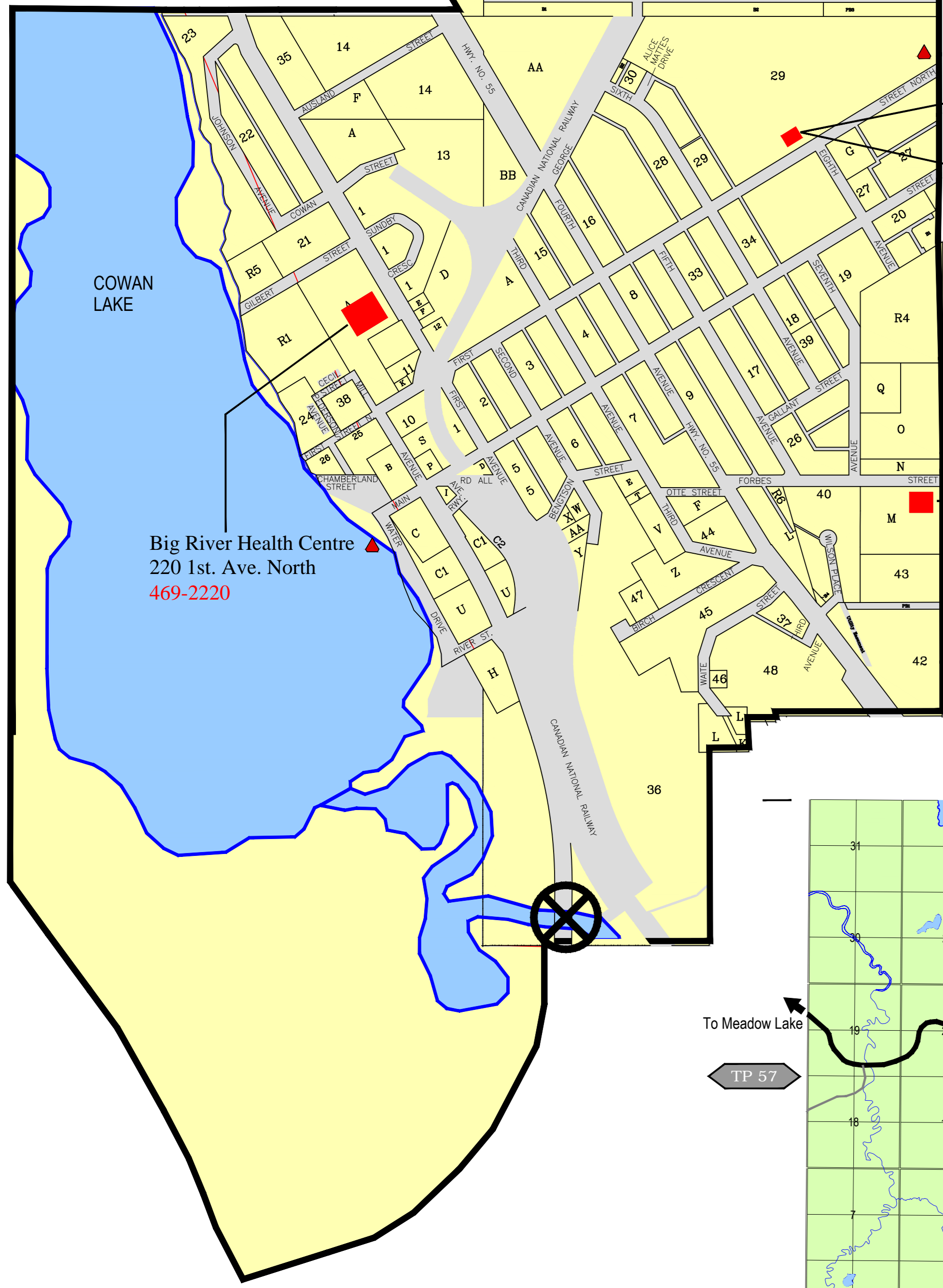

Town of Big River

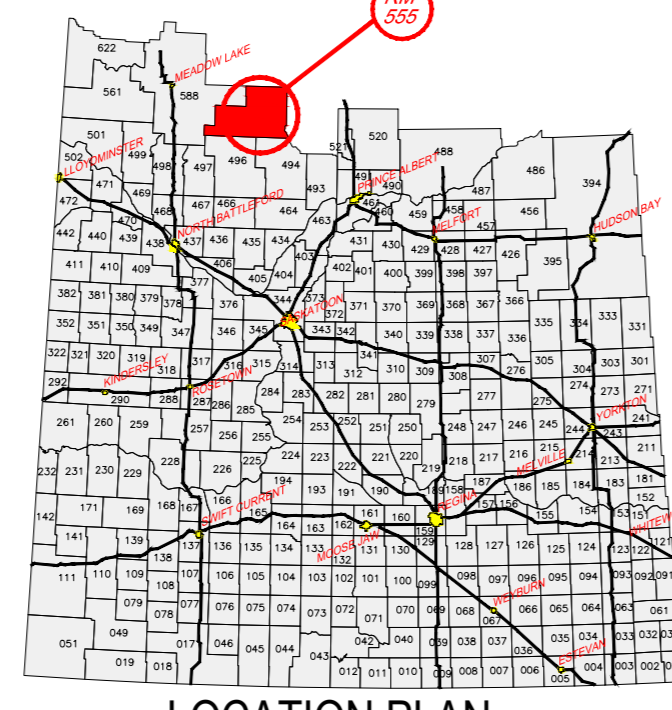
