A BYLAW OF THE TOWN OF BIG RIVER TO AMEND BYLAW 2015-02 ZONING BYLAW


The Council of the Town of Big River, in the Province of Saskatchewan, hereby Amends Bylaw 2015-02 as follows:

1. The Zoning District Map referred to in Section 8.2 and forming part of the Zoning Bylaw is amended by rezoning Block 14 Plan BB1645 Ext. 1 and 2 as shown within the bold dashed line on the map below from R1- Low Density Residential District and C2-Arterial Commercial District to wholly R1-Low Density Residential District.



2. This bylaw shall come into force and take effect upon approval of Bylaw 2016-02 by the Minister of Government Relations.

Read a first time this 15th day of August, 2016.
Read a second time this 19th day of September, 2016.
Read a third time and adopted this 19th day of September, 2016.

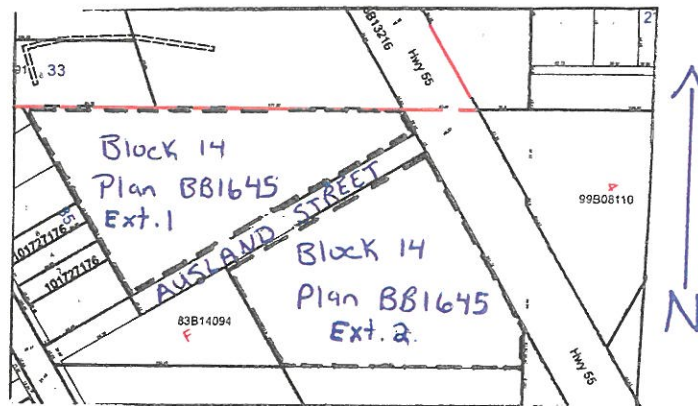

A BYLAW OF THE TOWN OF BIG RIVER TO AMEND BYLAW 2015-01 THE OFFICIAL COMMUNITY PLAN

The Council of the Town of Big River, in the Province of Saskatchewan, hereby Amends Bylaw 2015-01 as follows:

1. Appendix A Figures 6 and 7- Land Use Designation Plan Maps to redesignate Block 14, Plan BB1645, Ext. 1 and 2, as shown within the bold dashed line on the map below from Arterial Commercial and Residential land use area to wholly Residential land use area.



2. This bylaw shall come into force and take effect when upon approval from the Minister of Government Relations.
