- 1. The remaining Parcel B Plan 88B11407 abuts Highway 55. It does not appear that the parcel would be suitable for development and meet required setbacks the Ministry of Highways may require;
- 2. It appears proposed Parcel G is limited to a suitable building site when municipal and highways setbacks are taken into consideration;
- 3. There appears to be double frontage along both proposed parcels F & G;
- 4. Proposed parcel F is not showing a garage that is located south of the house and should be included on the plan of proposed subdivision so its exact location may be determined;
- 5. There is a pole shed that encroaches on the municipal road allowance in proposed parcel F that should be removed;
- 6. A service agreement will be required for the subdivision that will include, among other things offsite fees of \$2,000.00 per lot;
- 7. Section 14 of *The Public Health Act, 1994* outlines the responsibilities of municipalities as it pertains to a system for sewage disposal which the Town of Big River and the RM of Big River, No. 555 have addressed collectively by virtue of an agreement dated November 10th, 2008 which also provides that the agreement will be readdressed if capacity becomes an issue;
- 8. Council has no information about the ground water supply in the area;
- 9. Potable water is available at a cost at the Town of Big River fill station;
- 10. The RM of Big River has transfer station locations to accommodate garbage disposal;
- 11. The lands are currently used to feed and house horses which would not be permitted in a Resort Residential District;
- 12. A zoning amendment may be drafted to rezone the area to a Resort Residential District if the plan of proposed subdivision can be revised to accommodate Council's concerns.
