Fuel Clause: crushing price is with fuel at \$1.05 per liter. If diesel fuel exceeds \$1.10 per liter at time of crushing, a charge of \$0.05 per cubic yard will be added to the crushing price. This charge will be added for every \$0.05 per liter increase thereafter.

If crushing of 3,000 cubic yards of 1½" crushed road gravel is required it will be completed for the same rates as quoted above (\$4.00 per cubic yard plus Jaw crushing and/or Screening if required.)
