- 6. The plan of proposed subdivision shall require an amendment to accommodate, a turnaround to be registered as roadway for the motoring traffic and municipal equipment; and
- 7. A service agreement shall be required to include, but not limited to, upgrading the existing 66 foot right of way and developing the turn around to a municipal standard (Schedule B of the Service Agreement); and
- 8. Offsite fees shall also be required by the service agreement in the amount of \$2,000.00 for the new parcel being created; and
- 9. Council will not require an engineered drainage plan or road profiles prepared by a professional engineer due to the topography and distance of construction, however, drainage shall be taken into consideration during construction and shall meet with Council approval.
