Whereas municipalities are finding it impossible in getting the Ministry of Highways Highway Traffic Officers doing weight enforcement on municipal roads; and

Whereas Municipalities are being told to hire their own Community Safety Officer (CSO) and train them in weights and measures; and

Whereas a CSO even if hired by a municipality is limited with respect to tools they may carry in often confrontational situations;

Therefore be it resolved SARM lobby the Provincial Government mandate their Highway Traffic Officers to be more receptive and involved with assisting municipalities enforcing overweight loads being hauled on municipal roads."
