- 1. Council is not aware of any site conditions that would make the land unsuitable for the intended use; and
- 2. The RM does not have any facilities that could be affected by the proposed residential site; and
- 3. Council has no objection to the proposed subdivision as it may be considered under Clause 3.6.2.3(d) (ii) of RM of Big River, No. 555 Official Community Plan to permit a site size of 16.582 ha (40.98 acres) that exceeds the maximum 10 ha within an agriculture district for single detached dwellings to accommodate an existing farm yard site; and
- 4. The said subdivision may be considered for estate planning under Clause 3.5.2.2(b) (v) of Bylaw 1/16 the RM of Big River, No. 555 Official Community Plan; and
- 5. Localized flooding on agriculture land is not uncommon; as such, current and future landowners should take this into consideration and make themselves aware of the site conditions when developing or farming the land; and
- 6. No service agreement will be required as the subdivision is not creating an additional site.
