

RURAL MUNICIPALITY OF BIG RIVER NO. 555

BYLAW NO. 4/21

A BYLAW OF THE RURAL MUNICIPALITY OF BIG RIVER, NO. 555 IN THE PROVINCE OF SASKATCHEWAN TO ESTABLISH MILL RATE FACTORS

The Council of the Rural Municipality of Big River, No. 555 in the Province of Saskatchewan enacts as follows:

- 1. This bylaw shall be known as the "Mill Rate Factor Bylaw".
- 2. The following mill rate factor shall be applied to the uniform mill rate levied against all taxable property in the following classes of assessment of property for municipal purposes:

Class of Assessment	Mill Rate Factor
Commercial and Industrial	2.6

(Example: taxable assessment x mill rate/ $1000 \times mill$ rate factor = taxes)

3. That Bylaw 6/19 is hereby repealed.

4. This Bylaw shall come into effect January 1, 2021.
