A BYLAW OF THE RURAL MUNICIPALITY OF BIG RIVER NO.555 TO AMEND ZONING BYLAW NO. 1/19 KNOWN AS THE ZONING BYLAW OF THE RURAL MUNICIPALITY OF BIG RIVER NO.555.

The Council of the Rural Municipality of Big River No.555 in the Province of Saskatchewan hereby amends Bylaw No. 1/19 as follows:

- 1. The Zoning District Map, referred to in Section 5.2 of Bylaw 1/19 is amended to rezone from A Agriculture to CR1 Low Density Country Residential District the following land:
  - a. In NW-03-55-07-W3 all of the proposed Parcel "B" as shown within the bold dashed line on the attached Plan of Survey dated, March 4<sup>th</sup>, 2021, prepared by Matthew J. Rustad, S.L.S., Meridian Surveys Ltd., and referenced as Map "A".

2. This bylaw shall come into force and take effect when approved by the Minister of Government Relations.
