RURAL MUNICIPALITY OF BIG RIVER NO. 555 BYLAW NO. 22-10-09

A BYLAW TO AMEND BYLAW 1/19 KNOWN AS THE ZONING BYLAW. (Lakeshore RV)

The Council of the Rural Municipality of Big River No. 555, in the Province of Saskatchewan, enacts as follows:

- 1. The Zoning District Map, referred to in Section 5.2 of Bylaw 1/19 is to be amended to rezone the following:
 - a) In NE 36-57-07 W3, all of the proposed Lots 1 to 21, Block 12 and Lots 1 to 5, Block 13 and Public Laneways, as shown within the bold dashed line on the attached Plan of Survey dated, July 7th, 2022, prepared by Calvin W. A. Bourassa, S.L.S., GeoVerra Inc., and referenced as Exhibit "A" from RPM (H) Park Model Residential District H to RPM Park Model Residential District; and
 - b) In NE 36-57-07 W3, all of Parcel H, as shown within the bold dashed line on the attached Plan of Survey dated, July 7th, 2022, prepared by Calvin W. A. Bourassa, S.L.S., GeoVerra Inc., and referenced as Exhibit "A" and to rezone C1 (H) Resort Commercial District H to C1 Resort Commercial District.
- 2. Bylaw 22-08-06 is hereby repealed.
- 3. This bylaw shall come into force and take effect upon final passing.


